Greenfield Union School District (GUSD) initiated a Reopening Task Force in 2020/2021 that consists of the executive cabinet team, two board members, all department directors, several support personnel, union leaders, and our community. Meetings are held biweekly via Zoom and will continue until the California Department of Public Health notifies the public and LEAs that the pandemic is over signifying that it is safe to return to all activities without added safety precautions in place.

During the GUSD Reopening Task Force meetings, community members, board members, and staff worked together to create all of our COVID-19 safety protocols. The Task Force continues to meet and refine the protocols to fit the changing guidelines so we are always prepared to provide a safe school for the students of Greenfield. The same protocols are used during extended learning opportunities such as Summer Camp, after school engagement opportunities and include distance learning protocols.

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
